PROTOCOL

BETWEEN JAPAN AND THE UNITED MEXICAN STATES RELATED TO IMPROVEMENT OF MARKET ACCESS CONDITIONS BASED ON PARAGRAPHS 3 AND 5 OF ARTICLE 5 OF THE AGREEMENT BETWEEN JAPAN AND THE UNITED MEXICAN STATES FOR THE STRENGTHENING OF THE ECONOMIC PARTNERSHIP

Japan and the United Mexican States,

Desiring to improve market access conditions on certain originating goods designated for consultation under subparagraphs 1(b), 4(b) and 10(b) of Sections 2 and 3 of Annex 1 of the Agreement between Japan and the United Mexican States for the Strengthening of the Economic Partnership, signed at Mexico City on September 17, 2004 (hereinafter referred to as "the Agreement"); and

Having negotiated in accordance with subparagraph 3(a)(i) and paragraph 5 of Article 5 of the Agreement;

Have agreed as follows:

Article 1

The Parties shall be bound by the aggregate quota quantity and the in-quota rate of Customs Duties established in Appendices 1 and 2, which shall constitute an integral part of this Protocol.

Article 2

Pursuant to paragraph 5 of Article 5 of the Agreement, Appendices 1 and 2 shall supersede the corresponding concessions provided for in subparagraphs 1(b), 4(b) and 10(b), and Schedules corresponding thereto, of Sections 2 and 3 of Annex 1 of the Agreement respectively.

Article 3

- 1. This Protocol shall be approved by the Parties in accordance with their respective legal procedures, pursuant to paragraph 5 of Article 5 of the Agreement, and enter into force on the thirtieth day after the date on which the Parties exchange diplomatic notes indicating such approval.
- 2. This Protocol shall continue in force as long as the Agreement remains in force.

Article 4

- 1. The texts of this Protocol in the Japanese, Spanish and English languages shall be equally authentic. In case of differences of interpretation, the English text shall prevail.
- 2. Notwithstanding paragraph 1 above:
 - (a) Appendix 1 is written in the Japanese and English languages, such texts being equally authentic; and
 - (b) Appendix 2 is written in the Spanish and English languages, such texts being equally authentic.

IN WITNESS WHEREOF, the undersigned, being duly authorized thereto by their respective Governments, have signed this Protocol.

Appendix 1

- 1. With regard to subparagraph (b) of Note 1 of Section 2 of Annex 1 of the Agreement, Japan shall apply a tariff rate quota for originating goods specified in the Schedule of Japan subject to the following:
 - (i) From the third year to the fifth year, the aggregate quota quantity shall be as follows, respectively:
 - (AA) 3,000 metric tons for the third year;
 - (BB) 4,000 metric tons for the fourth year; and
 - (CC) 6,000 metric tons for the fifth year.
 - (ii) The in-quota rate of Customs Duties applied during the period from the third year to the fifth year shall be as follows:
 - (AA) The in-quota rate of Customs Duties on originating goods indicated with one asterisk ("*") in the Column 2 shall be lower than the most-favored-nation applied rate of Customs Duty in effect at the beginning of the Japanese fiscal year 2003 by 10 percent of that most-favored-nation applied rate.
 - (BB) The in-quota rate of Customs Duties on originating goods indicated with two asterisks ("**") in the Column 2 shall be lower than the most-favored-nation applied rate of Customs Duty in effect at the beginning of the Japanese fiscal year of 2003 by 20 percent of that most-favored-nation applied rate.
 - (CC) The in-quota rate of Customs Duties on originating goods indicated with three asterisks ("***") in the Column 2 shall be lower than the most-favored-nation applied rate of Customs Duty in effect at the beginning of the Japanese fiscal year of 2003 by 40 percent of that most-favored-nation applied rate.
- 2. With regard to subparagraph (b) of Note 4 of Section 2 of Annex 1 of the Agreement, Japan shall apply a tariff rate quota for originating goods specified in the Schedule of Japan subject to the following:
 - (i) From the second year to the fifth year, the aggregate quota quantity shall be as follows, respectively:

- (AA) 2,500 metric tons for the second year;
- (BB) 4,000 metric tons for the third year;
- (CC) 6,000 metric tons for the fourth year; and
- (DD) 8,500 metric tons for the fifth year.
- (ii) The in-quota rate of Customs Duties applied during the second year shall be lower than the most-favored-nation applied rate of Customs Duty in effect at the beginning of the Japanese fiscal year 2004 by at least 10 percent of that most-favored-nation applied rate.
- (iii) The in-quota rate of Customs Duties applied during the period from the third year to the fifth year shall be as follows:
 - (AA) The in-quota rate of Customs Duties on originating goods indicated with one asterisk ("*") in the Column 2 shall be lower than the most-favored-nation applied rate of Customs Duty in effect at the beginning of the Japanese fiscal year 2004 by 10 percent of that most-favored-nation applied rate.
 - (BB) The in-quota rate of Customs Duties on originating goods indicated with two asterisks ("**") in the Column 2 shall be lower than the most-favored-nation applied rate of Customs Duty in effect at the beginning of the Japanese fiscal year of 2004 by 20 percent of that most-favored-nation applied rate.
 - (CC) The in-quota rate of Customs Duties on originating goods indicated with three asterisks ("***") in the Column 2 shall be lower than the most-favored-nation applied rate of Customs Duty in effect at the beginning of the Japanese fiscal year of 2004 by 28.5 percent of that most-favored-nation applied rate.

- (DD) The in-quota rate of Customs Duties on originating goods indicated with four asterisks ("****") in the Column 2 shall be lower than the most-favored-nation applied rate of Customs Duty in effect at the beginning of the Japanese fiscal year of 2004 by 40 percent of that most-favored-nation applied rate.
- 3. With regard to subparagraph (b) of Note 10 of Section 2 of Annex 1 of the Agreement, Japan shall apply a tariff rate quota for originating goods specified in the Schedule of Japan subject to the following:
 - (i) From the third year to the fifth year, the aggregate quota quantity shall be as follows, respectively:
 - (AA) 2,000 metric tons for the third year;
 - (BB) 3,000 metric tons for the fourth year; and
 - (CC) 4,000 metric tons for the fifth year.
 - (ii) The in-quota rate of Customs Duties applied during the period from the third year to the fifth year shall be lower than the most-favored-nation applied rate of Customs Duty in effect at the beginning of the Japanese fiscal year of 2004 by 50 percent of that most-favored-nation applied rate.

Appendix 2

- 1. With regard to subparagraph (b) of Note 1 of Section 3 of Annex 1 of the Agreement, the United Mexican States (hereinafter referred to as "Mexico") shall apply a tariff rate quota for originating goods specified in the Schedule of Mexico subject to the following:
 - (i) From the third year to the fifth year, the aggregate quota quantity shall be as follows, respectively:
 - (AA) 3,000 metric tons for the third year;
 - (BB) 4,000 metric tons for the fourth year; and
 - (CC) 6,000 metric tons for the fifth year.
 - (ii) The in-quota rate of Customs Duties applied during the period from the third year to the fifth year shall be as follows:
 - (AA) The in-quota rate of Customs Duties on originating goods indicated with one asterisk ("*") in the column 2 shall be lower than the most-favored-nation applied rate of Customs Duty in effect as of January 1, 2003 by 10 percent of that most-favored-nation applied rate.
 - (BB) The in-quota rate of Customs Duties on originating goods indicated with two asterisks ("**") in the column 2 shall be lower than the most-favored-nation applied rate of Customs Duty in effect at the beginning of January 1, 2003 by 20 percent of that most-favored-nation applied rate.
 - (CC) The in-quota rate of Customs Duties on originating goods indicated with three asterisks ("***") in the column 2 shall be lower than the most-favored-nation applied rate of Customs Duty in effect at the beginning of January 1, 2003 by 40 percent of that most-favored-nation applied rate.
- 2. With regard to subparagraph (b) of Note 4 of Section 3 of Annex 1 of the Agreement, Mexico shall apply a tariff rate quota for originating goods specified in the Schedule of Mexico subject to the following:

- (i) From the second year to the fifth year, the aggregate quota quantity shall be as follows, respectively:
 - (AA) 2,500 metric tons for the second year;
 - (BB) 4,000 metric tons for the third year;
 - (CC) 6,000 metric tons for the fourth year; and
 - (DD) 8,500 metric tons for the fifth year.
- (ii) The in-quota rate of Customs Duties applied during the second year shall be lower than the most-favored-nation applied rate of Customs Duty in effect as of January 1, 2004 by at least 10 percent of that most-favored-nation applied rate.
- (iii) The in-quota rate of Customs Duties applied
 during the period from the third year to the
 fifth year shall be as follows:
 - (AA) The in-quota rate of Customs Duties on originating goods indicated with one asterisk ("*") in the column 2 shall be lower than the most-favored-nation applied rate of Customs Duty in effect as of January 1, 2004 by 10 percent of that most-favored-nation applied rate.
 - (BB) The in-quota rate of Customs Duties on originating goods indicated with two asterisks ("**") in the column 2 shall be lower than the most-favored-nation applied rate of Customs Duty in effect as of January 1, 2004 by 20 percent of that most-favored-nation applied rate.
 - (CC) The in-quota rate of Customs Duties on originating goods indicated with three asterisks ("***") in the column 2 shall be lower than the most-favored-nation applied rate of Customs Duty in effect as of January 1, 2004 by 28.5 percent of that most-favored-nation applied rate.
 - (DD) The in-quota rate of Customs Duties on originating goods indicated with four asterisks ("****") in the column 2 shall be lower than the most-favored-nation applied rate of Customs Duty in effect as of January 1, 2004 by 40 percent of that most-favorednation applied rate.
- 3. With regard to subparagraph (b) of Note 10 of Section 3 of Annex 1 of the Agreement, Mexico shall apply a tariff rate quota for originating goods specified in the Schedule

of Mexico subject to the following:

- (i) From the third year to the fifth year, the aggregate quota quantity shall be as follows, respectively:
 - (AA) 2,000 metric tons for the third year;
 - (BB) 3,000 metric tons for the fourth year; and
 - (CC) 4,000 metric tons for the fifth year.
- (ii) The in-quota rate of Customs Duties applied during the period from the third year to the fifth year shall be lower than the most-favored-nation applied rate of Customs Duty in effect as of January 1, 2004 by 50 percent of that most-favored-nation applied rate.
